

TERMS AND POLICIES

Attendance Policy: Please note that attendees are not permitted to distribute any materials if you do not have reserved booth space. Anyone found distributing materials will be asked to leave and will not receive a refund.

Cancellation Policy: If a registrant must cancel his or her registration, the registrant must do so by 5:00 p.m. PDT, August 31, 2010, for a 50% refund of paid registration fees. Cancellation requests must be submitted in writing to regquestions@confreg.com. Fees for registrations cancelled after September 1, 2010 are non-refundable. All cancellations entitled to a refund will be processed within one month after the event. No-shows will be charged the full conference fee.

In the unlikely event Devcon 2010 is cancelled, each registrant is entitled to a full refund of their registration fees.
